

**Subject: Information notices issued by Vetagro S.p.A. – a single member company  
in accordance with Article 13 of the European Regulation 2016/679**

**Given that**

We inform you that, following your request to receive our periodic newsletter, our company will collect and process certain of your personal data.

We hereby specify, for clarity, the following definitions given by the European Regulation 2016/679:

**Personal Data:** any information concerning an identified or identifiable natural person ("data subject"); an identifiable natural person is one who can be identified, directly or indirectly, in particular by reference to an identifier such as a name, an identification number, location data, an online identifier, or one or more factors specific to the physical, physiological, genetic, mental, economic, cultural, or social identity of that natural person.

**Processing:** any operation or set of operations which is performed on personal data or on sets of personal data, whether or not by automated means, such as collection, recording, organization, structuring, storage, adaptation or alteration, retrieval, consultation, use, disclosure by transmission, dissemination, or otherwise making available, alignment or combination, restriction, erasure, or destruction.

All of the above being stated, according to Article 13 of the European Regulation 2016/679, we inform you that the collection and processing of your personal data in this section of the website will be carried out by our company in accordance with the following:

- a) Purpose: The data will be processed solely for sending you the periodic newsletter as requested by you.
- b) Methods: The data will be processed both with paper and electronic/information technology/telematic tools, fully complying with the law, according to principles of lawfulness and fairness, and ensuring your confidentiality.
- c) Optional provision: Providing your data is optional and not obligatory.
- d) Consequences of refusal: Refusing to provide the data or not giving consent for their processing, as mentioned in this information notice, will unfortunately prevent us from sending you the newsletter.
- e) Subjects or categories of recipients to whom the data may be communicated or disclosed: The data may be communicated to third parties only to fulfill legal obligations or to satisfy your requests. The data will not be disclosed in any case.
- f) Persons authorized to process: The data will be processed solely by a limited number of company employees, specifically authorized.
- g) Automated decision-making processes (e.g., profiling): No automated decision-making processes are managed in any way.
- h) Rights of the data subject: You have all the rights provided by the European Regulation 2016/679, including the right to request access to personal data and their rectification, erasure of the same, restriction of processing, the right to object to their processing, as well as the right to data portability. You also have the right to lodge a complaint with the Supervisory Authority.
- i) Transfers to third countries: Any transfer of personal data to a third country outside the European Union or to an international organization will be based on an adequacy decision of the Commission or, in the case of transfers referred to in Articles 46, 47, or 49, paragraph 2, of the European Regulation, on appropriate and suitable guarantees.
- j) Data retention period: The data will be kept for the period strictly necessary to meet your requests or based on what is provided for by current regulations or any contractual clauses.
- k) Data Controller: The data controller is Vetagro S.p.A. - Società a unico socio, with registered office in Reggio Emilia (RE), Via Porro n. 2, represented by the legal representative pro tempore.
